Capitalised terms have the meaning given in the Schedule, unless otherwise stated. If there's any inconsistency between these terms and the Schedule, then what's in the Schedule is correct. By submitting your entry, you agree that these Conditions of Entry apply to your entry.
- 2. The promoter is Victorian Cricket Association (trading as Cricket Victoria) ABN 28 004 128 812 of CitiPower Centre Junction Oval, Lakeside Drive, St Kilda VIC, 3182 ('*Promoter'*, 'we', 'us').
- Victorian Cricket Association (trading as Cricket Victoria) is a Declared Organisation in Victoria and holds a Victorian Commission for Gambling and Liquor Regulation (the VCGLR) declaration number 42963 under Chapter 8 of the Gambling Regulation Act 2003.
- 4. Any updates to these Conditions of Entry will be published on our website [www.melbournestars.com.au/competitions], so it's important to check these Conditions of Entry regularly.

## Who can enter ... and who can't

5. The eligibility requirements for this Promotion are set out in the Entry Restrictions. Directors, managers, employees, officers, agents and contractors of the Promoter, and their immediate families (ie spouse, partner, parent, grandparent, natural or adopted child, and sibling (whether natural or adopted by a parent)) are ineligible to enter.

#### How to enter

- We will not accept entries which are incomplete, illegible, or which are generated by computers or other automated means.
- 8. We reserve the right to disqualify your entry in the event of non-compliance with these Conditions of Entry, failure to meet any content guidelines set out in the Entry Procedure, or if (in our reasonable opinion), you tamper or interfere with an entry mechanism in any way.
- 9.
