## Terms and Conditions of Entry for the Melbourne Stars Promotion

### First up

1. These terms and the Schedule form the Conditions of Entry for this Promotion and set out all of the information you need to know regarding this Promotion. 3. Victorian Cricket Association (trading as Cricket Victoria) is a Declared Organisation in Victoria and holds a Victorian Commission for Gambling and Liquor Regulation (the VCGLR) declaration number 42963 under Chapter 8 of the Gambling Regulation Act 2003.

### Who can enter ... and who can't

5. The eligibility requirements for this Promotion are set out in the Entry Restrictions. Directors, managers, employees, officers, agents and contractors of the Promoter, and their immediate families (ie spouse, partner, parent, grandparent, natural or adopted child, and sibling (whether natural or adopted by a parent)) are ineligible to enter.
