3. Victorian Cricket Association (trading as Cricket Victoria) is a Declared Organisation in Victoria and holds a Victorian Commission for Gambling and Liquor Regulation (the VCGLR) declaration number 42963 under Chapter 8 of the Gambling Regulation Act 2003.

### Who can enter ... and who can't

5. The eligibility requirements for this Promotion are set out in the Entry Restrictions.
