3. Victorian Cricket Association (trading as Cricket Victoria) is a Declared Organisation in Victoria and holds a Victorian Commission for Gambling and Liquor Regulation (the VCGLR) declaration number 42963 under Chapter 8 of the Gambling Regulation Act 2003.

### Who can enter ... and who can't

5. The eligibility requirements for this Promotion are set out in the Entry Restrictions. Directors, managers, employees, officers, agents and contractors of the Promoter, and their immediate families (ie spouse, partner, parent, grandparent, natural or adopted child, and sibling (whether natural or adopted by a parent)) are ineligible to enter.
